Discover Dubai Itinerary

Day 1: Overnight Flight to Dubai

Today board your overnight flight to Dubai.

Day 2: Arrive Dubai, United Arab Emirates (UAE)

Arrive in Dubai, clear customs and meet your **Tour Director**. Check-in to your hotel for a 7 night stay. This evening enjoy a **Welcome Dinner**.

Day 3: Dubai City Tour

Today enjoy a **Dubai City Tour**. Dubai is a city of ages that rises out of the desert and crowns the gulf coast with its presence. See the magnificent view of **Dubai Creek**, passing by the heritage area of **Bastakia**, with its fascinating old Wind Towered Houses built by wealthy merchants. We will have our stop at the 180 year old **Fort Al Fahidi**. Here Dubai Museum records the city's past with all its developing stages. We continue our journey by **Abra**, a traditional boat and cross the creek towards the **Spice Market** followed by **Gold Souk**. Next, travel to the top of the tallest building in the world, the **Burj Khalifa**. Return to Dubai and enjoy the afternoon at leisure. Tonight enjoy a **Dhow Dinner Cruise**, a traditionally decorated wooden boat that will sail along the Dubai Creek under the moonlight.

Day 4: Dubai - East Coast Tour

On our way to the East Coast, we pass through the agricultural areas of **Al Dhaid**, and terrain changes from colorful desert landscape to spectacular mountain scenery. The coastline is scattered with small fishing villages, including the old village of **Dibba**, once a strategically important settlement with a stunning view across the Indian Ocean. Continuing along the coastline, we arrive at the **Al Bidya Mosque**, the oldest mosque in the country built in the 15th century. Then we pass the port towns of **Khorfakkan** and **Fujairah**, passing by the ruins of the mountain dwellers and the 300-year-old **Fort of Fujairah**, and the fortress of nearby Bithnah Oasis.

Day 5: Dubai - Abu Dhabi Tour

From Dubai we travel past the world's largest man made port at **Jebel Ali** enroute to **Abu Dhabi**. You will be mesmerized by the grandness of the majestic **Grand Mosque**, the third largest mosque in the world. We then visit the **Cultural Foundation** at the heart of the city next to the famous Union Square that gathers symbolic themes inspired by the customs of the country. After a drive along the Corniche, we will visit the **Heritage Village**, specially designed by late HH Sheikh Zayed Ben Sultan al Nahyan, as reminder of the past for the younger generation. Return to Dubai and enjoy the evening at leisure.

Day 6: Dubai at Leisure

Enjoy the day at leisure in Dubai to shop and explore on your own. Perhaps take a leisurely stroll along Dubai's vast coastline this morning or head to one of Dubai's famous malls for shopping.

Day 7: Dubai - Sharjah & Desert Safari Experience

Sharjah is an exciting, lively city with colorful souks filled with interesting artifacts in every corner. You will first visit the **"Al Noor Mosque"** – the first mosque in Sharjah to open its doors for non-Muslim residents and tourists. We will conclude the tour with a stop at **Qanat Al Qasba**, one of the most beautiful walking areas in Sharjah, where you can indulge on Arabic coffee, tea, sweets and the famous "Kunafah" to then have a panoramic view of the whole city from **Sharjah Eye**. Today also enjoy a **Desert Safari Adventure**. Our safari gives you an opportunity to see the golden sand dunes of Arabia in 4-wheel drives vehicles where you experience the thrill of a lifetime. We arrive to our **Bedouin Campsite**, in the heart of the desert. Adding to the atmosphere of the night, enjoy cultural performances while partaking in a **BBQ Farewell Dinner**.
