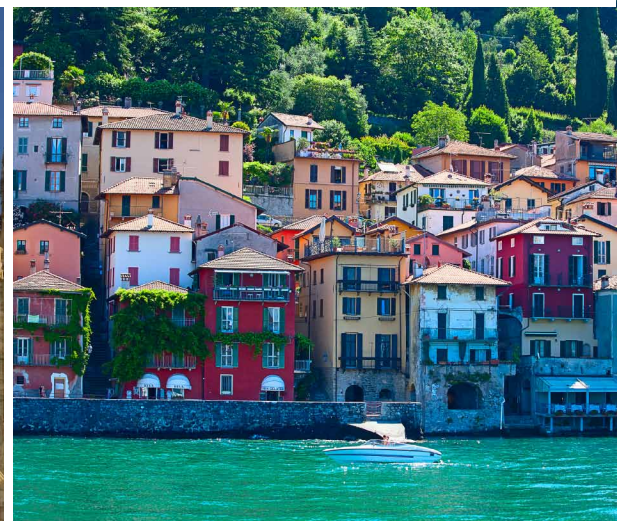
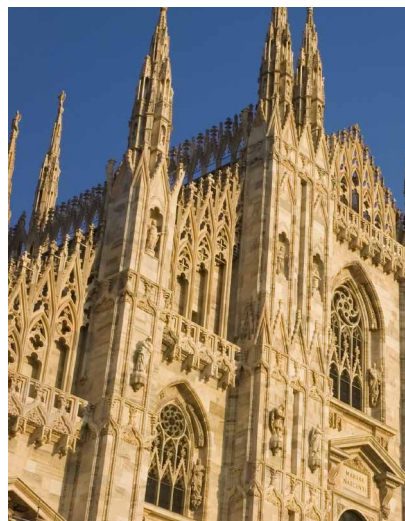

## DAY 1: Overnight Flight to Europe/Italy
