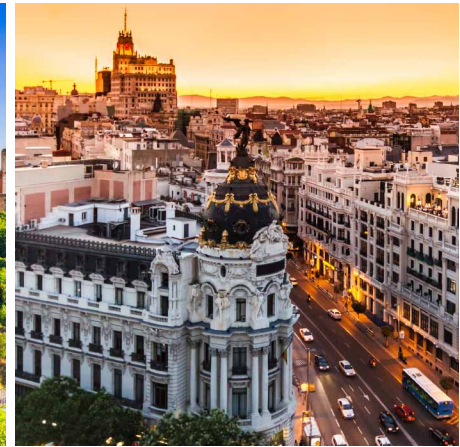

Day 1: Overnight Flight

Board your overnight flight to Europe.

Day 2: Arrive Lisbon

One of the most brilliant jewels of universal architecture, the **Alhambra**, is a series of palaces and gardens built under the Nazari Dynasty in the 14th Century. Muslim and Jewish cultures. Visit the **Toledo Cathedral**, one of the three 13th-century High Gothic cathedrals in Spain. Later arrive in **Madrid** for a 2-night stay in one of Europe's great capital cities and a center of art, finance, culture and history.

The capital since 1561, Madrid is a perfect blend of modern and old world.
